The most exciting event of this last year was completing the West River Road Riverbank and Habitat Restoration project in partnership with the town of Barkhamsted, CT DEP, the Farmington River Anglers' Association and FRWA. The project culminated in two volunteer planting days. This 200-foot stabilization project leveraged \$10,000 of FRCC contribution with local and state resources valued at over \$80,000.

## Accomplishments FY 2003

The Farmington River Coordinating Committee was established by U.S. Congress to oversee and coordinate activities on the 14-mile federally designated Wild and Scenic section of the upper Farmington River. Each year the FRCC receives funding from Congress to fulfill its mandate. The Upper Farmington River Management Plan guides the actions of the Committee – and others who have an interest in stewardship of the river. The headings below represent the categories of the Upper Farmington River Management Plan – and the items are accomplishments of the FRCC during the past fiscal year (October 1 – September 30).

### Resource Conservation

- ❖ Completed West River Road stabilization and restoration project with town of Barkhamsted and CT DEP.
- ❖ Completed two volunteer river bank planting days at West River Road site.
- ❖ Initiated plans for a 14-mile riverbank assessment.
- ❖ Continued work with communities to improve understanding of and implementation of the local riverfront protection overlay districts.
- ❖ Co-sponsored (with CT Farmland Trust) a regional land trust forum.

### Education and Outreach

- ❖ Held Open House at new office space at Squires Tavern.
- ❖ Provided presentation of Farmington W&S River Economic Study results.
- ❖ The FRCC Small Grants Program provided funding for:
  - Grant writer for New Hartford's Downtown Riverwalk project.
  - Storm drain markers for Miles Groth's Eagle Scout badge project in Barkhamsted.
  - New Hartford Open Space brochure.
  - Northwest Conservation District Farmington River Business Education Program.
  - Farmington River Anglers Association's support to the Connecticut River Salmon Association's Classroom Project.
- ❖ Completed the new FRCC web site – [www.farmingtonriver.org](http://www.farmingtonriver.org).
- ❖ Completed installation of nine informational kiosks along fourteen miles of river.
- ❖ Published and distributed new FRCC newsletter to over 300 riverfront land owners and town leaders.

- ❖ Provided an educational display at the Peoples State Forest 100<sup>th</sup> Anniversary Celebration and at the Riverton Fair.

### **Advocacy/Public Forum**

- ❖ Provided comments on the following projects:
  - Proposed Habitat Enhancement at Boneyard pool (a popular fishing location in New Hartford).
  - Proposed Gravel pit in New Hartford on Farmington Turnpike.
- ❖ Met with Representatives Nancy Johnson and John Larson to provide an annual update on river management progress.

### **Administration**

- ❖ Developed a new membership policy and integrated it into FRCC bylaws.
- ❖ Participated in the National River Rally in Stevenson, WA.
- ❖ Worked with FRWA to complete up-to-date riverfront landowners mailing list.
- ❖ Held an organizational planning retreat to review management plan accomplishments and improve organizational structure.
- ❖ Met with the other seven national Partnership Rivers to discuss strategy and tactic for successful river management.

### **Recreational Management**

- ❖ Provided assistance to the town of New Hartford in planning for a downtown riverwalk.
