## Annual Report 2007

### Greetings from the banks of the Farmington Wild & Scenic River

In 2007, the Farmington River Coordinating Committee continued to work on projects that reflect the outstanding resource values that are the foundation of the Wild and Scenic designation.

Our most exciting new project for 2007, in the opinion of this old retired teacher, was awarding our first Nancy Johnson Scholarships. We were looking for a student interested in an environmental science and we found two! Erin Guzowski was a high school student at Northwestern Regional 7 High School and is majoring in Geology at Keene State College in New Hampshire; the second student, Kai Starn, is a Natural Resource Planning major at the University of Vermont. The scholarships were created both to honor Nancy Johnson (who in her role as a member of the House of Representatives, introduced and supported the designation of the Farmington as a Wild and Scenic River) and to promote the pursuit of environmental education. Mrs. Johnson attended our Open House in September and presented the scholarships to the parents of the recipients.

Several other excellent projects were completed this year. In an effort to collect and document data on the health of the 14-mile stretch of W&S Farmington River, FRCC contracted with Ethan Nedeau of Biodrawversity to study the distribution and habitat of fresh water mussels, snails, and crayfish. Nedeau determined that the Farmington is exemplary habitat for certain species.



FRCC funded a much-needed bank stabilization project in the Nepaug Forest that was also finished — thanks to the great work of DEP and local excavator Gene Allen. The MDC also lent support to that project.

Our Grants Program funded two Fish in the Classroom projects this year - one for Farmington River Anglers Association to fund the CT River Salmon Association's Salmon in the Classroom project at the Colebrook Consolidated School, and the other for Farmington Valley Chapter Trout Unlimited to fund the Trout in the Classroom project at the Hunter Montessori School (Caren Ross – Teacher) in New Hartford.

The 3rd Annual Open House and Wild & Scenic Art Exhibit was held in September, and the art work was stunning. The Traveling Trout, the Barkhamsted Land Trust musical group, entertained, and the food and drink was enjoyed by all. If you missed it in 2007, please plan to attend in 2008 (probably in September). Squires Tavern is a great place for a party!

Long term projects such as Water Quality Monitoring, Invasive Plant Management, completion of the information kiosks on the river, the FRCC Grants Program, and on-going support of the restoration of Squires Tavern will progress in 2008.

## ACCOMPLISHMENTS 2007

### Outreach and Education

**Nancy Johnson Scholarships**—Scholarships were awarded to Kai Starn and Erin Guzowski.

**FRCC Open House and W&S Art Exhibit** — The 3rd FRCC Annual Open House and W&S Art Exhibit was a great success. Our favorite local band, *Traveling Trout* of Barkhamsted Land Trust, serenaded us again. There were 32 pieces of art—by 17 local artists or photographers.



**FRCC Newsletter** — FRCC produced and distributed two newsletters to more than 400 riverfront landowners, town officials and organizations.

### Resource Stewardship

**Nepaug Riverbank Stabilization**—Work that was badly needed to stabilize a riverbank and road in Nepaug State Forest was completed thanks to a cooperative effort between FRCC, CT DEP, and MDC. Local excavator—Eugene Allen—did a wonderful job blending the stabilization work into the forest's natural surroundings.

**Mussels, Snails and Crayfish Study**—FRCC contracted with Ethan Nedeau of Biodiversity to study the distribution and habitat of fresh water mussels, snails, and crayfish in the upper Farmington. Nedeau determined that the Farmington is exemplary habitat for certain species. Please see our website for more information.

**Macroinvertebrate Study**—FRCC contributed to a macroinvertebrate study being done by FRWA and CT DEP. Results from that study will be available next year.



**Water Quality Monitoring**—Upper Farmington River WQM continues regularly thanks to Alisa Phillips-Griggs at FRWA and MDC. This year's testing showed no major changes from the year before.

**Vernal Pools in Canton** — Initial studies were done in identifying vernal pools in Canton. The final stages of this project will take place in 2008.

**Mapping**—FRCC outfitted itself with some working GIS maps to assist in all kinds of discussions and projects. Jeff Bolton, FRWA's new GIS mapper, created an aerial map showing parcel boundaries for each town, and an upper watershed map showing protected lands, property boundaries, water resource features, and roads.

**Hartland Natural Resources Inventory**—FRCC assisted Hartland in completing a Natural Resources Inventory for that town.

**Flushing Flows Study**— A study was completed by Melinda Daniels at UConn to determine what level of flow would be needed to move sediments on the upper Farmington River.
