Regular FRCC Meeting Minutes Monday, June 17, 2019 7:00 pm Hogback/Goodwin Dam Picnic Area

- Scholarship presentation began at 6:03 PM followed by Potluck dinner.
- **1. Regular Business Meeting called to order at** 6:53PM by Chair Bowler following paddle, scholarship presentation and potluck.
- 2. Approval of Minutes: Minutes of May 20, 2019 meeting were consensually approved at 7:07PM.
- **3. Treasurer's Report:** Farmington River Watershed Association (the fiscal agent of FRCC) staff prepared the treasurer's report dated 5/16/2019, which was presented by Hart and Sinish. The beginning total balance was \$17,440.54. Funds received included a QBE insurance refund of \$25.00 and a transfer of \$25,000.00 from NPS CA funds (Leaving an available FY19 NPS budgeted account balance of \$55,000.00.) \$12,226.97 from FRCC checking paid for the Lower Farmington website fee, Wildcat Creek band fee, internship stipend, phone bill, and FRWA water quality monitoring. The ending total balance was \$30,502.12 (checking \$27, 307.48 and scholarship fund \$3, 194.64). The report was approved.

 - Status of Pending Grants \$500.00 was approved as FRCC share of cost of FALPs trail maps reprint.
- -Resource/Stewardship: Active Project Updates -
 - Activities at Colebrook Lake Dam No new info. All advised to read UFRMP. FRCC to have a statement in the near future regarding future management of flows. NPS working on background information with Army Corps.
 - Butler Farm Easement Committee discussed latest language regarding the surface of the trail.
